NOTICE INVITING TENDERS (NIT)

Online tenders are invited from reputed service providers/ firms engaged in installation of security and surveillance systems, hereinafter referred as 'The Bidder/ Vendor' registered under Company Act 1956, (Now companies Act, 2013) for the below works. The Bidder should be a profitable registered company/ firm involved in supply, installation & maintenance of CCTV Systems and Security (Burglar) Alarm Systems for at least three (03) years and not blacklisted by any Bank or other entity either for substandard equipment or for poor monthly maintenance service.

Central Monitoring Software (CMS)

The Vendor should provide Central Monitoring Software (CMS) Solution to monitor the health and functioning of all Security Systems (NVR/DVRs) or Controlling units to be set up at a central location (RBO/ HO) at no additional cost to the Bank. This CMS Solution should be IP based and should be accessible from at least two PCs at Regional Offices/ Head Office. The CMS should be implemented and demonstrated after successful installation of 25 branches at our Regional Offices or IT Cell, at Hyderabad/ Sangareddy.

The software should generate daily health status reports of all the installed Security system or NVR/ DVRs or the controlling unit and send through email to the designated officials automatically. Minimum health status required is:

- a) Functioning status of Security System or NVR/DVR
- b) Functioning status of each and every camera
- c) Functioning status of each and every Hard Disk
- d) Status of recording
- e) Date-wise number of days of recorded data available
- f) If down, since when and the reasons

Further, the CMS should have the below mandatory features;

- a) Clock synchronization of Security System or NVR/DVR with that of server.
- b) Restart the Security System or NVR/DVR from CMS.
- c) Preview and playback feature of the cameras.
- d) Accessing NVR/DVR configuration window from CMS.
- e) NVR/DVR quick search feature.
- f) Capture the snapshot of the camera/s & pull the Footage from CMS.
- g) Sending SMS to the saved numbers (in case of malfunction of NVR/DVR system).

- h) Real time monitoring as well as schedule monitoring.
- i) Giving rights to different users with different privileges.
- j) Generating Management Information System (MIS) reports.
- k) No restriction on the number of channels to be linked.
- l) A pop-up for the following alerts should appear on the screen and should be able to export as a report in Excel format.

- Ping failure
- Router error
- Signal error
- Record error of the Camera/s
- Hard Disk/s error
- Port error
- Login error
- No Error
- Change of System configuration from Motion Detection mode to Regular mode

The bank will also need weekly and monthly consolidated reports which are auto generated and sent by emails. The report formats shall be arrived through discussions during the installation phase. In addition to the above, the software should generate the following reports:

- a) Branch-wise details of non-functional NVR/DVRs and accessories, where issues are not resolved within 24hrs.
- b) Branch-wise details, where recording is not taking place.
- c) Branch-wise details, where recording is not available for 90 days.
- d) Branch-wise details, where the cable has been disconnected from DVR.

CCTV SYSTEMS:

CMS: CCTV / NVR Systems should be CMS ready with INTRANET & INTERNET.

- a. NVRs should be 8 or 16 Channel.
- b. NVR should facilitate to anchor two - 4 TB Hard Disks or more
- c. NVR should be INTRANET compatible & INTERNET ready

COMPATIBILITY: The units should be compatible to be INTEGRATED with BURGLAR ALARM Systems.

APPLICATION SOFTWARE: The software (APP) for mobile phone should be absolutely free of cost and should be upgraded/ improved for any future applications at no further cost for remote operation.

BURGLAR ALARM SYSTEMS:

CMS: Burglar Alarm Systems should be CMS ready with INTRANET & INTERNET.

- a) The Bank shall obtain the SIM, if needed.
- b) In case of CMS establishment, the vendor should be able to provide technical personnel at our center as under:
 - i) 8-Hour service on working days (9.00PM to 5.00AM).
 - ii) 24-Hour service on Holidays.
 - iii) Who shall monitor regularly and resolve the issues at the locations/ branches.
- c) **CMS Software:** The software for CMS should be absolutely free of cost and should be upgraded/ improved for any future applications at no further cost.

SIM PROCUREMENT: The SIMs shall be procured by the Bank from the provider (BSNL/AIRTEL or any other) as per the availability of the signal & connectivity.

Facility Management Services (FMS)

The Bank shall also avail the services of the successful vendor for the Facility Management of Security System remotely from a central location (FTS Center, RBO/ HO). Hence, the vendor shall also offer Facility Management Services (FMS) through CMS to extend the service support and monitoring of NVR/ DVRs, at various locations in the Bank, by deploying one Service Engineer for one shift from Monday to Saturday (from 10:00 AM to 06:00 PM) at their own cost to achieve the following objectives:

1. Remotely monitoring the working of the Security System, Cameras, Hard disks, Hubs and other related hardware, software as per the requirements of the Bank, through their Central Monitoring Software from the Bank's FTS Center, RO/ HO Hyderabad.
2. Providing footages through video clippings to the Bank officials for producing the same as evidence to the Law Enforcing Authorities.
3. To remotely PING and TELNET the DVR system to check proper connectivity to CMS and to query proper establishment of connection to TCP port.
4. Configuring the DVR in Motion Detection mode, if the same is configured in Regular Mode.

Annexure-V: Rates for providing personnel to CMS.

1. BIDDERS' ELIGIBILITY CRITERIA:

- i) The Bidder should be a profitable Registered Company/ firm involved in **SUPPLY, INSTALLATION AND AMC OF STAND ALONE DIGITAL IP BASED CCTV SYSTEMS WITH NVR AND SECURITY (BURGLAR) ALARM SYSTEMS** for at least three (3) years. The firm should have minimum annual turnover of Rs.25,00,000.00 (Rupees Twenty Five Lakhs Only) for the years ending 31st March 2023, 31st March 2024 & 31st March 2025. The bidder/ vendor have to submit copy of audited or CA Certified Balance sheet, Profit & Loss statement and trading account details for these financial years.
- ii) "The Bidder will have to submit documentary evidences confirming that they have minimum experience of three years having successfully completed the similar work costing not less than the amount equal to Rs.15,00,000.00 (Rupees Fifteen Lakhs Only) i.e. **SUPPLY, INSTALLATION AND AMC OF STAND ALONE DIGITAL IP BASED CCTV CAMERA SYSTEMS WITH NVR AND SECURITY (BURGLAR) ALARM SYSTEMS for Govt./ PSU/ Banking & Other Institutions** (Attach supporting documents)".
- iii) Bank may assign to install or up gradation of NVR, CCTV IP cameras, hard disk, PoE switch as per the security requirement of branches during tender/ contract validity period i.e. two years from the date of allotment of tenders.
- iv) The bidder should have service centers in Bank's operational area. The proof of the same is to be enclosed to the Technical bid.
- v) The bidder shall submit feedback/satisfactory performance reports from at least two banks, duly signed and stamped on the respective bank's letterhead.
- vi) The bidder must have prior experience in providing Annual Maintenance Contract (AMC) services for both CCTV and Burglar Alarm Systems in a minimum of two scheduled commercial banks. Relevant work orders and completion certificates may be submitted as proof of experience.

2. Terms And Conditions:

- a) **Quoted Product for** the PARTS/ SPARE PARTS FOR REPLACEMENT QUOTED FOR DIGITAL IP BASED CCTV SYSTEMS should be from one principal company. If any vendor/ firm quoted for two different principal companies for the said products, their bids will be summarily rejected.

- b) **Quoted Product for** the PARTS/ SPARE PARTS FOR REPLACEMENT QUOTED FOR SECURITY (BURGLAR) ALARM SYSTEMS should be from one principal company. If any vendor/ firm quoted for two different principal companies for the said products, their bids will be summarily rejected.
- c) **Warranty:** The product offered by the vendor must be covered under a comprehensive onsite warranty for a period of three years from the date of installation. During this warranty period, the vendor shall be responsible for rectifying any defects or malfunctions in the product at the installation site itself, without any additional cost to the Bank. The onsite warranty should include free replacement or repair of any defective parts, labour charges, and travel expenses incurred by the service personnel. The vendor must ensure prompt and efficient after-sales support throughout the warranty period to minimize downtime and ensure uninterrupted operations.

“However, the Annual Maintenance Contract (AMC) will commence only after the completion of the warranty period. During the warranty period, the bidder/vendor shall be responsible for providing maintenance services free of cost”.

- d) Bidders should undertake to provide the Bank Annual Maintenance Contract (AMC) of Digital IP based CCTV Camera systems and Security (Burglar) Alarm Systems functioning in 493 existing branches and administrative offices of Telangana Grameena Bank for two (02) years, including replacement of parts/ spare parts (where irreparable situation arises) in above said branches as and when required as per the rates quoted. Further, the SUCCESSFUL BIDDER HAS TO CONDUCT QUARTERLY PREVENTIVE MAINTENANCE VISITS to ensure proper functioning of CCTV Camera systems and Security (Burglar) Alarm Systems.
- e) The Bidder shall cover all the hardware and any software accompanying the hardware and included in the cost thereof. Besides, the successful Bidder shall have to attend to all break-down calls within 24 hours within the Service Area of Telangana Grameena Bank.

3. **Indemnity clause:**

- a) The bidder/ vendor represents and warrants that the repair and maintenance service to be provided do not violate or infringe upon any patent, copyright, trade secret, or other proprietary right of any other person or other entity. The bidder/ vendor agrees that it will, and hereby does, indemnify the Bank from any claim, damages, loss, penalty etc., directly or indirectly resulting from or arising out of any breach or claimed breach of this tender/ work order/ Agreement.

- b) The bidder/ vendor agrees to indemnify and hereby keeps the Bank indemnified against all claims, suit or proceedings and against all actions, loss, damages, frauds, reputation loss, costs, expenses, charges, including legal expenses (Attorney, Advocates fees included) which the Bank may suffer or incur on account of any deficiency in services rendered by the bidder/ vendor or breach of any obligations mentioned in clauses hereinabove, including without limitation, breach of confidentiality obligations or any acts of commission / omission on the part of the employees, agents, representatives or Sub-Contractors, etc of the bidder/ vendor. The bidder/ vendor agrees to make good the loss suffered by the Bank on first demand made by the Bank in this regard which shall be final conclusive and binding on the bidder/ Vendor.
- c) It will be the sole responsibility of the bidder/ vendor to ensure that he complies with all the applicable Central/ State legal provisions for hiring his staff to provide the services to the Bank, and the bank authorities shall be compensated/ indemnified by the bidder/ vendor, if any violation is detected by any authority and any penalty (monetary or otherwise)/ cost is imposed upon/ suffered by any of the bank authorities due to non- compliance by the bidder/ vendor.
- d) The bidder/ vendor acknowledge that all material and information which has or will come into its possession or knowledge in connection with this tender/ work order/ Agreement or in performance thereof, consists of confidential and proprietary data, whose disclosure to or use by third parties will be damaging or cause loss to the Bank. The bidder/ vendor agrees to hold such material and information in strictest confidence, not to make use thereof other than for the performance of this tender/ work order/ Agreement, to release or disclose it only to bidder's/ vendor's employees requiring such information, and not to release or disclose it to any third party. The bidder/ vendor agrees to take appropriate steps/ action with respect to its employees to ensure that the obligations of non-use and non-disclosure of confidential information under this tender/ work order/ Agreement are fully satisfied and if any loss caused to the Bank by such acts of the employees, agents, representatives or Sub-Contractors, etc of the bidder/ vendor, the bidder/ vendor shall indemnify the Bank.
- e) The bidder/ vendor further undertakes to promptly notify the Bank in writing any breach of obligation of the tender/ work order/ Agreement by its employees, agents, representatives or Sub-Contractors, etc including confidentiality obligation and in such an event, the Bank will in addition to and without prejudice to any other available remedies be entitled to immediate equitable relief in a Court of competent jurisdiction to protect its interest including injunctive relief.

- f) The bidder/ vendor shall be directly and vicariously liable to indemnify the Bank in case of any misuse of data/ information of the Bank by the bidder/ vendor or any of its officials or representatives deliberate or otherwise and this includes intangible / reputation losses of the Bank.
- g) The bidder/ vendor shall indemnify and keep fully and effectively indemnified the Bank from time to time for all costs, fine, penalties, expenses or damages, etc. that the Bank incurred as a result of any violation of any provisions/ clauses of the tender/ work order/ Agreement or negligence by the bidder/ vendor or against any fine or penalty levied on the Bank for improper payment of tax for the reasons attributable to the bidder/ vendor.
- h) The bidder/ vendor hereby undertakes the responsibility to take all possible measures, at no additional cost, to avoid or rectify any issues which thereby results in non-performance of software/ hardware/ deliverables within reasonable time. The Bank shall report as far as possible all material defects to the bidder/ vendor without undue delay. The bidder/ vendor also undertake to co-operate with other service providers thereby ensuring expected performance covered under scope of work.
- i) Nothing contained in this tender/ work order/ Agreement shall impair the Bank's right to claim damages without any limitation for an amount equal to the loss suffered for non-performance of software.
- j) The Bidders and their respective officers, employees, agents, and advisers shall observe the highest standard of ethics during the tender process and contract period. Notwithstanding anything to the contrary contained in this tender/ work order/ agreement, the Bank shall reject a Proposal without being liable in any manner whatsoever to the bidder/ vendor, if it determines that the Bidder has, directly or indirectly or through an agent, engaged in corrupt practice, fraudulent practice, coercive practice, undesirable practice, or restrictive practice (collectively the "Prohibited Practices"). In such an event, the Bank shall, without prejudice to its any other rights or remedies, forfeit and appropriate the Bid Security (EMD) or Performance Security, as the case may be, as mutually agreed genuine pre-estimated compensation and damages payable to the Bank for, inter alia, time, cost, and effort of the Bank, in regard to the tender process, including consideration and evaluation of such Bidder's Proposal.
- k) The work order/ Agreement shall be effective from the date thereof and shall continue till expiration or termination of the work order/ agreement due to cessation of the business relationship between the parties. However, the obligation of the bidder/ vendor and any of its officials or representatives to keep

the Confidential Information in confidence shall continue to be binding and applicable without limit in time except and until such information enters the public domain.

4. ANNUAL MAINTENANCE CONTRACT:

- a) AMC charges inclusive of preventive maintenance visits at quarterly intervals, maintenance and support, repairs and replacements of defective parts/ kits/ items/ for tender period, (i.e., two (02) years) should be quoted inclusive of taxes in the financial bid.
- b) During AMC period the Bidder should ensure 90 days or more backup of CCTV cameras at all the locations at any given point of time as per RBI guidelines.
- c) Bank may assign to install or additional/ up-gradation of CCTV IP cameras, Hard Disk, NVR and PoE Switch as per the security requirement of RBOs/ branches during AMC tender validity period i.e. two (02) years from the date of allotment of tenders/ contract.
- d) During AMC period, the Bidder should ensure that the cameras installed should cover maximum area and all corners of the bank and also to check 128 GB/64 GB memory card installed at branches for functioning and recording.
- e) The Make and model of Parts/ Spare parts requiring replacement for DIGITAL IP BASED CCTV CAMERA SYSTEMS AND SECURITY (BURGLAR) ALARM SYSTEMS quoted (**Annexure-I**) should be of good quality and standard type.
- f) The bidder/ vendor will have to mandatorily provide quarterly branch/ administrative office visits and have to arrange any number of on-call/ emergency visits without any charge on registering the complaint by the bank, even if preventive visit was done during the quarterly period.
- g) If the Bank desires to shift the equipment to a new site and install it there at urgently, the bidder/ vendor shall be informed of the same. The bidder/ vendor shall arrange to do so. The terms and conditions of this tender/ work order/ Agreement, after such shifting and re-installation, would continue to be binding on the bidder/ vendor. The shifting charges of the CCTV system and Security (Burglar) Alarm Systems shall be as per approved rates.
- h) Technical specification sheet of each item for DIGITAL IP BASED-NVR/ Digital CCTV SYSTEMS AND SECURITY (BURGLAR) ALARM SYSTEMS as per Annexure-I should be attached and duly signed by the bidder along with Technical Bid.

- i) Subcontracting: The bidder/ vendor will not subcontract or permit anyone other than bidder's/ vendor's qualified personnel to perform any of the work, services or other performance required of bidder/ vendor under this tender/ work order/ agreement without the prior written consent of the Bank.
- j) The bidder should have service centers in Bank's operational area. The proof of the same is to be enclosed to the "Technical Bid".
- k) The bidder has to setup a "HELP DESK" for call registration and to provide users with call related information. One senior engineer among onsite staff shall be identified to work as call coordinator and manage Helpdesk operations.
- l) Undertaking by Bidder: We understand and undertake that mere submission of application does not guarantee us tender and Bank's decision in this regard will be final and binding on us.

5. LIABILITY CLAUSE:

- a) The bidder/ vendor hereby agrees and declares that it shall be the sole responsibility of bidder/ vendor to comply with the provisions of all the applicable laws, concerning or in relation to rendering of services by bidder/ vendor as envisaged under this tender/ work order/ Agreement.
- b) The bidder/ vendor shall be responsible for compliance of all related laws, rules/ regulations and Government instruction from time to time that are applicable for the service to be provided by it during the currency of this tender/ work order/ Agreement.
- c) The bidder/ vendor shall procure and maintain all necessary licenses permissions, approvals from the relevant authorities under the applicable laws throughout the currency of this tender/ work order/ Agreement.
- d) The bidder/ vendor shall be solely liable & responsible for compliance of applicable Labour Laws in respect of its employees, agents, representatives, Sub-Contractors, etc and in particular laws relating to terminal benefits such as Pension, Gratuity, Provident Fund, Bonus or other benefits to which they may be entitled and the Bank shall have no liability in this regard.
- e) The persons engaged by the bidder/ vendor shall not be the employees of the Bank and the Bank shall not be responsible in any manner for payment of wage remuneration nor payment for PF, EPF due to such employees. It shall be the sole responsibility of the bidder/ vendor to handle all issues relating to the personnel engaged by bidder/ vendor.

- f) The bidder/ vendor will take all safety measures/ precautions during the work. Any accident due to negligence or any other reasons shall be the responsibility of the bidder/ vendor and the Bank shall have no liability in this regard.
- g) The bidder/ vendor hereby represents and warrants that it has full authority to enter into this tender/ Agreement and render the services as envisaged under this tender/ work order/ Agreement and all Corporate or other necessary approvals have been obtained for entering into this tender/ Agreement with Bank. Further, the persons executing this tender/ Agreement on behalf of the bidder/ vendor have full authority and power to execute this tender/ Agreement and bind the bidder/ vendor.

6. PAYMENT TERMS:

- a) The AMC charges will be paid quarterly by RBO/ Head Office upon satisfactory completion of quarterly Preventive Maintenance visits and visit as and when required subject to submission of visit reports duly authenticated by the branches/ administrative offices confirming satisfactory functioning of the systems. Consolidated AMC visit report of branches to be submitted to Head Office and respective Regional Business Offices.
- b) No advance amount will be paid along with the Work Order/ Letter of Intent.
- c) Applicable Tax Deducted at Source (TDS) will be deducted from the bills as per prevailing Government norms.
- d) PAYMENT: 90% of the invoice amount shall be paid on successful/ functional installation of the new units. 10% shall be held back as retention money (does not carry any interest) for performance guarantee for warranty period (3 years).

7. Penalty:

- a) Any complaint regarding repair and maintenance of CCTV cameras and Security (Burglar) Alarm Systems should be attended by the vendor within 4 hours and it should be resolved within 24 hours. Vendor will be required to pay penalty as per clauses mentioned in tender document, if repair/ replacement works of defective equipment does not take place within the stipulated period as per tender document.
- b) In case the bidder is unable to repair the equipment and suitable standby is not provided, BANK reserves the option of getting the systems repaired and cost of repair incurred will be imposed as penalty.

- c) If service of bidder/ vendor is found unsatisfactory, bank will have right to terminate this agreement and forfeit the Earnest Money Deposit/Performance Guarantee submitted by the bidder.

8. Applicable Law:

- a) The tender shall be interpreted in accordance with applicable laws and shall be subject to the exclusive jurisdiction of courts at Hyderabad.
- b) Authorized signatory of the Bidder should duly sign and stamp each page of the Tender there by acknowledging acceptance of the terms & conditions.
- c) The Successful bidder shall sign an agreement within seven (7) days from the date of acceptance of the tender with the bank in the prescribed form.
- d) Dispute resolution: Any and all disputes, difference, controversies and conflicts ("Disputes") whatsoever arising between the parties out of or in connection with the tender/ work order/ Agreement or the performance or non-performance of the rights and obligations set forth herein, or the breach, termination, invalidity or interpretation thereof shall be referred for arbitration in terms of the Arbitration and Conciliation Act, 1996 (Arbitration Act) or any amendments thereof. Prior to submitting the disputes to arbitration the parties shall make all endeavors to settle the dispute/s through mutual negotiation and discussions. In the event that the said dispute/s are not settled within 30 days of the arising thereof as evidenced through the first written communication from any party notifying the other regarding the disputes, the same shall finally be settled and determined by arbitration as above.
- e) The place of arbitration shall be at Hyderabad and the language used in the arbitral proceedings shall be English. Arbitration shall be conducted by a mutually appointed sole arbitrator. If the Parties are unable to agree upon a sole Arbitrator, each Party shall appoint one arbitrator and the two arbitrators so appointed by the Parties shall appoint the third arbitrator, who shall be the Chairman of the Arbitral Tribunal.
- f) The arbitral award shall be in writing and subject to the provisions of the Arbitration and Conciliation Act, 1996. The award of the arbitrator shall be final and conclusive and binding upon the Parties.
- g) Pending the submission to arbitration and thereafter, till the Arbitrator or the Arbitral Tribunal renders the award or decision, the parties shall, except in the

event of termination of this Agreement or in the event of any interim order/ award is granted under the afore stated Act, continue to perform their obligations under this Agreement.

9. Termination:

- a) The tender/ work order/ Agreement shall be terminated by efflux of time or earlier by the Bank by serving 30 days notice in writing in case the services of the bidder/ vendor is found unsatisfactory or not in accordance with the tender/ work order/ Agreement or there is any breach of the terms and conditions of the tender/ work order/ Agreement on the part of the bidder/ vendor or for convenience.
- b) The bidder/ vendor goes bankrupt and becomes insolvent.
- c) If during the currency of the tender/ work order/ Agreement, any statute, rules/ Govt. notification prohibits the services envisaged under this tender/ work order/ Agreement or otherwise the contract shall come to an end forthwith and no compensation shall be payable to the bidder/ vendor.

10. COPYRIGHT / LICENSE VIOLATIONS & PROVISION OF LEGAL COPIES:

- a) Bidders shall explicitly absolve the Bank of any responsibility and indemnify the Bank. Bidders should unconditionally absolve the bank of any responsibility and indemnify bank against any liability for the use of system OS (Operating System) and software with regard to copyright/license if any. Whenever the hardware is supplied with preloaded OS appropriate LTU (License to Use)/paper license with necessary media for each of the system shall be provided.
- b) Bidder has to submit a certificate from the manufacturers along with technical specifications that they are the authorized agents for the sale and service of their product and manufacturer undertakes to support the bidder in supply of required spares.
- c) Bidder will have to submit a certificate from the manufacturer that the spare parts for the supplied product will be available for after sales service.

11. OTHER TERMS AND CONDITIONS:

- a) The acceptance of the tender shall rest with the Purchase Committee, which does not bind itself to accept the lowest or any particular tender. The Committee reserves the right to reject any or all tenders received without assigning any reason whatsoever. Any tender that fails to comply with the prescribed conditions or is incomplete in any respect is liable to be rejected.
- b) In case the successful bidder fails to undertake the work, the earnest money/ performance guarantee deposited by them will be forfeited and acceptance of their tender will be withdrawn.
- c) Any item of the work in part or full may be deleted from the tender during execution as per bank's requirements and the decision of the Bank will be final.
- d) Rates quoted should be valid for a period of two years from date of work order/ contract.
- e) The Bidder should quote their (own) rates for undertaking the work. No escalation in rates will be allowed under any circumstances during the contract period.

- i) The bidder/ vendor shall repair / replace the defective equipment with standby equipment within the timelines given in tender document, and restore operation. The bidder/ vendor and any of its officials or representatives shall not without the prior written consent of the Bank or as expressly permitted herein, disclose, publish or reveal or cause it to be disclosed, published or revealed or make available to any other person, or use or allow others to disclose or use, the confidential information in any manner whatsoever.
- o) The Successful Bidder should support the Bank in taking the back up of the CCTV Camera footage and co-ordinate with the police officials in case of any theft/ requirement of the bank.
- p) All repair and maintenance service described herein shall be performed by qualified maintenance engineers totally familiar with the EQUIPMENT.
- q) The bidder has to setup "HELP DESK" for call registration and to provide call related information to users. One Senior Engineer among onsite staff shall be identified to work as call coordinator and manage Helpdesk.
- r) Any worn-out or defective parts withdrawn from the equipment and replaced by the bidder shall be handed over at the branch.

- s) On account of any negligence, commission or omission by the engineers of the bidder and if any loss or damage caused to the equipment, the bidder shall indemnify/pay/reimburse the loss suffered by the Bank.
- t) The bidder/vendor will not without the prior written consent of the Bank subcontract or permit anyone other than the bidder personnel to perform any of the work, services or other performance required.
- u) The bidder/ vendor acknowledge that all material and information which has or will come into its possession or knowledge in connection with this tender or in performance thereof, consists of confidential and proprietary data, whose disclosure to or use by third parties will be damaging or cause loss to Bank. The bidder/ vendor agrees to hold such material and information in strictest confidence, not to make use thereof other than for the performance of this tender, to release or disclose it only to bidder's/ vendor's employees requiring such information and not to release or discloses it to any third party. The bidder/ vendor agrees to take appropriate steps/action with respect to its employees to ensure that the obligations of non-use and non-disclosure of confidential information under this tender are fully satisfied and if any loss caused to the Bank by such acts of the employees, agents, representatives, etc. of the bidder/ vendor, the bidder/ vendor shall indemnify the Bank.
- v) The bidder/vendor shall strictly adhere to all prevailing labour laws inclusive of contract labour (regulation and abolition act of 1970) and other safety regulations. The bidder shall comply with the provision of all labour legislation including the latest requirements of all the Acts, laws, any other regulations that are applicable to the execution of the work order.

The bidder/vendor shall take all precautions for safety and protection of his employees on the works and shall comply with all applicable provisions of Government and local bodies' safety laws and relevant building codes to prevent accidents, or injuries to persons or property of about or adjacent to his place of work.
- aa) Even though bidders may satisfy the above requirements, they may be disqualified, if they have made misleading or false representation or facts or deliberately suppressed the information to be provided in the forms, statements and enclosures of this document. If they have record of poor performance such as abandoning work, not properly completing the contract, financial failures/ weaknesses, etc. In such cases, the Bank has the right to cancel or modify the tender.
- bb) The AMC charges and shifting charges for CCTV Systems and Security (Burglar) Alarm Systems have been finalized by the Bank in line with prevailing market rates. Bidders/vendors are advised to thoroughly examine and accept these rates prior to participating in the tender process, as no revision will be entertained at a later stage.
- cc) The Bank, at its sole discretion, may invite the L-2 bidder/ vendor to match the L-1 rates discovered during the tender process. In the event that the L-2 bidder agrees to match the L-1 rates, the Bank reserves the right to distribute the total order quantity between the L-1 and L-2 vendors in a 60:40 ratio, with 60% allocated to L-1 and 40% to L-2. 15. OPENING AND EVALUATION OF BIDS:

OPENING OF BIDS:

1. The Technical Bid/ Tender will be opened on 16.07.2025 (Wednesday) at 4:00 P.M. Any change in opening date and time will be notified by the Bank in advance. After opening of the Technical Bid/ Tender, during technical evaluation, if any further clarifications are warranted, the same should be submitted physically to the Telangana Grameena Bank, Head Office, Hyderabad by the bidders/ vendors within 48 hrs otherwise their tender documents will be summarily rejected. 17. Other clauses:
