General Rules and Conditions for Interested Applicants:

Telangana Grameena Bank invites applications from eligible retired officers for Appointment as Consultant Engineer. The eligibility criteria and terms are as follows:

- **1. Eligibility**: Retired engineers (Civil) from CPWD / PWD / State Government / Central Government / Central PSU / SCBs are eligible.
 - a. The applicant must have retired on or before 30.06.2025 and must be maximum of 65 years old as of 30.06.2025.
 - b. Officers who took voluntary retirement (VRS) or retired for personal reasons before the regular retirement age must have completed a minimum of 20 years of service.
- Officers should not have any pending departmental or legal proceedings during the last 5 years of service. They should not be involved in any case with CBI or any investigative agency.
- **3.** Candidates must have sound physical health and a minimum of two years of relevant work experience in construction supervision / consultancy for bank-related works.
- **4.** Experience in project management / site supervision / technical inspection will be preferred.
- **5.** Preference will be given to officers with prior experience of working in similar capacity in other banks or financial institutions.

Other Terms and Conditions:

- 1. Retired officers will be appointed purely on a contractual basis for supervision of the bank's construction projects.
- 2. Appointing the consultant engineer for other projects of the Bank is generally not permitted. However, depending on the bank's need and the applicant's performance, reappointment may be considered under special circumstances:
 - a) If the applicant's expertise is crucial and suitable alternatives are not available.
 - b) If there is urgency due to project completion or timelines.
- 3. The appointed person must sign a confidentiality and non-disclosure agreement. Information shared by the bank must not be disclosed or misused.

- 4. The appointed officer must enter into an agreement with the Bank in the proforma prescribed by the Bank.
- 5. Tasks and assignments will be given only as per the bank's instructions and approval.
- 6. No additional allowance, rent, fuel, or other expenses will be paid apart from what is fixed.
- 7. Appointed officers cannot use the bank's name, logo, visiting card, letterhead, or stationery for any personal purpose.
- 8. The bank reserves the right to cancel or modify this Appointment process at any stage.
- 9. The bank's decision on qualification/experience and selection shall be final and binding.
- 10. In case of dispute, the decision of the General Manager (Administration), Telangana Grameena Bank will be final and binding.
- 11. Any legal jurisdiction will fall under Hyderabad (Telangana) district court.

Brief description of the project:

TGB is planning the construction of its **Head Office building** at its own plot in Uppal Bhagayath, Uppal, Hyderabad. The building will consist of **2 Cellars**, **1 Stilt**, **and 5 Floors** covering an approximate **area of 85,000 sft**. The project includes **comprehensive civil**, **interior**, **and building-associated works**. An architect has already been appointed for end-to-end architectural services.

In order to effectively oversee the functioning and performance of the appointed Architect and Contractors, the Bank requires specialized technical expertise to monitor the project from the initial stages, starting with the preparation of drawings and obtaining statutory approvals, through to the successful completion of the work.

Accordingly, it is proposed to engage the consultative and supervisory services of a qualified Engineer. This engagement will ensure close and continuous monitoring of all construction-related activities, adherence to quality standards, compliance with approved plans, and timely execution of the project.

Scope of Work for Appointed Consultant Engineer

The Appointed Engineer shall provide technical support and oversight for the Bank's Head Office construction project at Uppal, Hyderabad. The detailed scope of services includes:

a) Design Verification:

- Review architectural, structural, electrical, and interior drawings for feasibility and compliance with codes.
- Ensure that all designs and specifications adhere to sound engineering practices and safety standards.

b) Scrutiny of Estimates:

- Vetting of Bill of Quantities (BOQ), Review and validate the preliminary estimate prepared by the architect based on CPWD Plinth Area Rates and prevailing market rates.
- Examine the detailed estimate submitted by the architect as per prevailing market rates and approved drawings. Recommend necessary modifications or amendments for consideration by the Bank.

c) Tender Documentation:

- Scrutinize and ensure the completeness and accuracy of **tender documents** prepared and submitted by appointed architect, for various trades such as:
 - Civil Works
 - Interior Finishing
 - Electrical Installations
 - Air Conditioning Systems
 - Horticulture, Landscaping & other miscellaneous works.

d) Site Supervision & Quality Control:

- Periodic site visits to inspect work progress and quality.
- Ensure that construction and interior works adhere to design specifications and safety standards.
- Identify deviations and recommend corrective actions.

e) Site Measurement Checks:

- Cross-check measurements of works executed at site wherever deemed necessary, upon receipt of running and final bills from the architect or appointed contractors/subcontractors.
- Provide recommendations to the Bank regarding certification and payments.

f) Compliance and Record-Keeping:

 Advise the Bank on the maintenance of essential project-related records in accordance with the guidelines issued by the Central Vigilance Commission (CVC) and other applicable regulatory bodies.

g) Audit & Inspection Support:

- Extend support to the Bank in addressing queries or observations raised during inspections or audits conducted by the CVC, statutory/external auditors, or other regulatory authorities.
- Provide necessary clarifications, documents, and technical justifications related to the construction project, as and when required.
- Assist in the preparation of audit replies and ensure timely submission of required data.

h) Project Monitoring & Review:

- Act as a liaison between the Bank and various stakeholders (architects, contractors, vendors).
- Facilitate coordination between civil and interior teams to avoid scope conflicts or delays.
- Conduct periodic review meetings involving all stakeholders to update on project status.
- Monitor project progress regularly, coordinate with Bank officials, and provide technical suggestions to ensure **timely and quality completion** of the project.
- Monitor cost against approved budget and advise the Bank on any variance.

i) Final Handover & Defect Liability:

- Inspect completed works before handover and prepare snag/punch lists.
- Ensure rectification of defects before final acceptance.
- Review as-built drawings and O&M (Operation & Maintenance) manuals provided by contractors.
