- 1. Telangana Grameena Bank (TGB), Head Office, Hyderabad intends to award a contract for Supply, Installation, refilling and Annual Maintenance Contract for Fire Extinguishers at 934 branches and Administrative Offices situated in Telangana State for the period of 3 Years. The selection will be carried out through a two-stage bidding process—Technical and Financial —on the SBI e-Procurement platform.
- 2. Telangana Grameena Bank (TGB) has its Head Office, Hyderabad -500044. Bidders are advised to go through the tender documents carefully before quoting the rates. The bidders are advised to visit the HO/RBO/Branches and conduct survey of the existing conditions so as to familiarize themselves with the nature and scope of works to be carried out and get all clarifications as necessary from TGB before quoting their rates.
- 3. Tenders will be applied on SBI e-procurement platform only. The PART-I (Technical Bid) of the tender shall contain Technical Qualification bid (as per Section I, II, III & IV), along with proof of having submitted EMD; and terms & conditions in prescribed tender document. The PART—II of the tender shall contain only the financial bid in the prescribed format. No other terms & conditions should be there in the financial bid. If any terms & conditions are stipulated in the tender document, the tender shall summarily be rejected.
- 4. The PART-I (Technical Bid) of the tender shall be opened first on the date mentioned. Based on the Technical Qualification bid / tender, the financial bids (Part- II) for competitive rates of eligible bidders will only be opened / considered
- 5. TGB reserves the right to accept or reject any tender, in whole or in part and it is not binding on the part of the TGB to accept the lowest (L1) or any tender.
- 6. Tenders, which do not fulfill all or any of the TGB's conditions or are incomplete in any respect and tenders with the bidders own conditions other than those specified by TGB, are liable to be rejected.
- 7. Any discrepancies, omissions, ambiguities in the tender documents, if any, or any doubt as to their meaning should be reported through mail.

- 8. Bank will review the same and if required, TGB will issue clarifications to the bidders which will become part of the contract document. TGB will not be responsible if the discrepancies, omissions, ambiguities in the Tender Documents or any doubts as to their meaning are not brought to the notice of TGB before three working days prior to the date of submission of the Tender.
- 9. The bidder shall deposit Earnest Money Deposit (EMD) amounting to **Rs.50,000/- (Rupees Fifty thousand only)**, by DD favouring Telangana Grameena Bank payable at Hyderabad, failing which, the bid will be rejected. No interest shall be paid on the EMD submitted by the bidders. EMD of unsuccessful bidders would be refunded after the award of work to the successful bidders. We request you to upload a copy of the DD along with tender document failing which the bid will not be considered for acceptance. MSE empanelled vendors and other eligible organizations will be exempted as per prevailing Govt. instructions upon submission of proof, failing which the bid will not be considered for acceptance.
- 10. Validity of offer should be 120 days from the date of opening of price bids. However, the rates quoted by the successful bidder would remain firm until the end of the contract period i.e. up to three (3) years from the agreement.
- 11. The successful bidder will be required to submit security deposit money @5% of the accepted value of tender including EMD amount as security.
- 12. The Security Deposit should be submitted within 15 days of award of work. The Earnest Money Deposit (EMD) of the successful bidder shall be adjusted towards Security Deposit. The Security Deposit will be released after 60 days from the expiry of the satisfactory supply & AMC period and will not bear any interest.
- 13. The Security Deposit will be liable to be forfeited in case the Contractor commits any breach of any terms and conditions of the contract or fails to complete the work/ service.
- 14. Any deviation in the above procedures for submission of tender may attract disqualification of the vendor from the tendering process. Conditional Bids will not be considered and will be rejected out rightly. The bidder is advised to study the Tender Documents thoroughly. Submission of bid shall be deemed to have been submitted after careful study & examination of Tender Document with full understanding of its implications. Bid without valid signature & stamp will be rejected.
- 15. Any clarification issued by TGB will be in the form of an addendum/ corrigendum and will be available on bank's website as well as SBI e-procurement platform. The amendment will be binding on all bidders.
- 16. The vendor should submit his tender well in advance so that last minute technical glitches can be avoided and TGB will not be responsible for failure of submission of tender by the bidders in this regard. "No extension of time will be permitted if the bidder is facing difficulty or facing technical issues in uploading the document at the fag-end of the time specified for closure of tender".

# INSTRUCTIONS TO THE BIDDERS FOR FURNISHING INFORMATION AS PART OF PRE-TENDER QUALIFICATIONS ELIGIBILITY CRITERIA:

The work involved is supply, installation, refilling and annual maintenance contract (AMC) for fire extinguishers at 934 branches and administrative offices of Telangana Grameena Bank situated in Telangana State. Scope of work and services to be provided are indicated in the "SPECIAL TERMS AND CONDITIONS – Scope of Work (Part A)" and "Scope of work (Part B) – Illustrative" of this tender. (The bidders are advised to visit all the sites (HO, RBO and branches), conduct survey of the existing arrangements to familiarize themselves with the nature of works to be carried out and get all clarifications as necessary from TGB before quoting their rates).

- 1. Authorized signatory of the Bidder should duly sign and stamp each page of the Tender there by acknowledging acceptance of the terms & conditions.
- 2. The Contractors should have experience of similar works for Central/ State Government offices/ Public Sector Undertakings/ Public Sector Banks during the last 3 years (ending 31.03.2025) and who fulfill the following criteria are eligible to tender:-
- Should have carried out **minimum 1 similar work** with Govt/ PSUs during last 3 years (ending 31.03.2025) with contract value (costing individually) not less than **Rs.10.00 lakhs**.

OR

Should have carried out **minimum 2 similar works** with Govt/ PSUs during last 3 years (ending 31.03.2025) with contract value (costing individually) not less than **Rs.5.00 lakhs** each.

OR

- Should have carried out **minimum 3 similar works** with Govt/ PSUs during last 3 years (ending 31.03.2025) with contract value (costing individually) not less than **Rs.3.50 lakhs** each.

  - 3. The bidders should have average Annual Turnover of **Rs.25 lakhs** during the last three years ending 31st March 2025 supported by Audited Balance Sheet or a registered Chartered Accountant certified statement of accounts.
  - 4. IT returns of last three consecutive financial years: 2022-23, 2023-24 & 2024-25.
  - 5. EMD/ MSE: The bidder has to deposit EMD in the form of DD/ Pay Order for Rs.50,000.00 (Rupees Fifty Thousand only) from any Scheduled Commercial Bank or Telangana Grameena Bank favoring "Telangana Grameena Bank, Head Office, Hyderabad. - 6. The bidder has to submit relevant ISO certificates pertaining to the offered products.
- 7. The bidders have to submit PAN, GST of the firm and licenses, permissions, approvals issued by appropriate authorities. Agency should have a valid license/ registration as per GOI instructions or from any other competent authority to operate a manpower agency in the State of Telangana and similarly registration with appropriate Competent Authority.

- 9. The bidder should submit feedback/ satisfactory performance reports from at least two public sector banks, duly signed and stamped on the respective bank's letterhead.
- 10. The bidder should submit a detailed escalation matrix with contact details.
- 11. **Manufacturer's Authorization Form**: Vendors, other than the manufacturers must submit a letter of authority [Original letter on letterhead of the OEM duly signed and stamped by its authorized signatories] from their manufacturers that they have been authorized to quote on behalf of the manufacturer.
- 12. The bidder should have service centers in Bank's operational area. The proof of the same is to be submitted.

- 1. All the pages of the Tender Document shall be signed by the Bidder. TGB takes no responsibility for delay/ loss in non-receipt of Tender Documents.
- 2. Bidders who have participated in the bidding process should be submit as Earnest Money Deposit (EMD) sum of Rs.50,000/- by DD in favour of Telangana Grameena Bank payable at Hyderabad. The EMD will be returned to the bidder if his tender is not accepted but without any interest, after finalization of work order. In no case EMD shall bear any interest. Under no circumstances, earnest money deposit will be accepted in the form of fixed deposit receipts or Banks or Insurance guarantee or cheque.
- 3. The Earnest Money Deposit paid by the successful bidder shall be held by the TGB as security for the execution and due fulfillment of the Contract. No interest shall be paid on the said deposit. In case of unsuccessful bidders, the EMD will be refunded only on award of Contract to the successful bidder. The EMD/ Initial Security Deposit (ISD) will not bear any interest. If the bidder withdraws his tender before expiry of the validity period of the tender or if the Contractor fails to execute/ complete the works satisfactorily, TGB reserves the right to forfeit the EMD / ISD.
- 4. Security Deposit of 5% of accepted value of the tender shall be deposited by the successful bidder within 15 days of intimation to him of acceptance of tender. The EMD already furnished shall be taken into account while determining the Security Deposit. In other words, EMD shall become a part of Security Deposit. The Security Deposit will be liable to be forfeited in case the Contractor commits any breach of any terms and conditions of the contract or fails to complete the work. This forfeiture is independent of the liquidated damages provided for in the contract.
- 5. The Security Deposit will be released after 60 days from the expiry of the satisfactory AMC period and will not bear any interest.
- 6. Bidders are advised to visit the site at their cost, conduct survey of existing conditions so as to familiarize themselves with the site conditions, nature of works etc. and get all clarifications as necessary from TGB before quoting the rates.
- 7. The Bidders should quote their rates strictly adhering to Terms and Conditions stipulated in the Tender Document. Unsolicited correspondence after opening of the tender shall not be entertained. Conditional/ Deviational Tenders may be rejected without making any reference to the bidders.
- 8. No Bidder will be allowed to withdraw his Tender during the validity period. Subletting of the Contract is not permitted. In case any bidder withdraws his/ her tender during the validity period or is subsequently found to have sublet the same, the EMD amount received from such bidders shall be forfeited.
- 9. Any form of canvassing/ lobbying/ influence/ query regarding short-listing, status, etc. will be a disqualification.

### **DECLARATION BY THE BIDDER**

- 1. I/we hereby declare that I/we have read and understood the General instructions, General conditions of Contract, detailed specifications and the conditions of work, etc. and hereby agree to abide by them.
- 2. I/we hereby confirm that the tender shall remain in force and valid for acceptance for a period of not less than 120 days from the date of opening of the financial bid.
- 3. I/we also note that any additions, clarifications, etc. which we would like to bring to your attention are put in a separate sealed covering letter. I/ we have ensured that only relevant entries asked for are made in the tender documents. Entries other than the relevant entry shall make the tender invalid.
- 4. I/we understand that if at any stage it is found/ noticed by the TGB that any information thus provided by us is untrue/ incorrect partly or fully, and in case of receipt of adverse/ unsatisfactory report from other clients/ Bankers, the TGB may not consider our application and/ or may de-list us and/ or may take any appropriate action against us.

### **GENERAL INSTRUCTIONS/ GENERAL CONDITIONS OF CONTRACT:**

- 1. Bidders are advised to visit the site and thoroughly understand the nature and scope of the works and be familiar with the site conditions before quoting.
- 2. Quoted rates should be workable and reasonable and should include incidental and all overheads and profits. The Contractor would be required to furnish an analysis for scrutiny of the Supply and Service Charges, as and when called for, by TGB.
- 3. The quoted rates shall be exclusive of GST but inclusive of transportation, labour charges, and all other associated costs. GST will be paid extra as applicable. No price escalation shall be permitted under any circumstances during the contract period, except for revisions arising from changes in GST or other statutory levies mandated by the Government.
- 4. Payment will be made region wise at RBO/ Head Office based on bill submitted by the Contractor and certified by the branches and RBOs to the effect that the Supply and AMC services are provided as per the contract agreement. The Contractor has to get the Signature of the Branch Manager on the service call report after completion of the respective work on the formats for respective work and should submit all these in original with the bill.
- 5. The bill has to be raised only for the completed Supply and service cycle (at yearly intervals) as indicated in the scope of work and the payment will be made for the completed service cycle amount as indicated in the financial bid by the Contractor on the pro-rata basis. Non-completion of service cycle will attract Liquidity damages.
- 6. Liquidated damages: Time is the essence of the contract and Liquidated Damages shall be recovered from the Contractor's dues for delay in completion of the service cycle on his part. The quantum of liquidated damages per week shall be calculated at 0.25% of the accepted tender value subject to a maximum 3% of the accepted tender amount.
- 7. Separate orders will be issued by TGB in respect of additional works (if any) which are not covered under the comprehensive charges. The bills for the same are to be submitted within a period of one month after completion of the work. TGB may reject any claim made after the stipulated period. The bills for the works carried out without proper work slips/ work order will be rejected and no further representation will be entertained.
- 8. GST-TDS, Income Tax, Works Contract Tax, Goods and Service Tax and other taxes as applicable, will be deducted from total payment due to the Contractors.
- 9. TGB will not be under any liability to pay any compensation to the persons deployed by the Contractor, if they sustain any injury etc., while discharging the duties in the said premises. The Contractor shall get them insured against any liability or any accident at its own cost. The Contractor should arrange to obtain necessary insurance cover for his employees at his cost and should be responsible for the safety of persons employed by him. The Contractor shall be fully responsible and shall compensate TGB in the event of any damage to person or material, injury/ damage or death as the case may be, caused directly or indirectly due to the negligence of the Contractor or his agents and / or his employees or workforce.

- 10. Any damages caused to the building/ premises during the execution of the work shall be made good by the Contractor and if necessary, through suitable Insurance cover at his cost.
- 11. The Contractor shall deploy such minimum number of qualified and experienced staff to ensure that the work is attended in time as per the scope of work of the tender, to the satisfaction of TGB
- 12. All the Standard Conditions of the Contract shall be binding on the parties as per Indian Contract Act and other prevailing Rules.
- 13. The Contractor shall, for all intents and purposes, be the "Employer" within the meaning of different Labour Legislations in respect of skilled and unskilled personnel so employed and deployed in TGB and the manpower so employed and deployed in TGB shall remain under the overall control and supervision of the Contractor. The persons deployed by the Contractor in TGB shall not have claims of Master and Servant relationship (implicitly or explicitly) between him/ her/ them and TGB nor have any principal and agent relationship with or against the TGB. The Contractor's personnel shall not claim any benefit/ compensation/ absorption/ regularization of services under the provision of the Industrial Disputes Act, 1947 or Contract Labour (Regulation & Abolition) Act, 1970 or any other act related thereto.
- 14. The Contractor shall comply with the provisions of Contract Labour (Regulation & Abolition) Act, 1970, Minimum Wages Act, 1948 and all other Labour Laws and other Statutory Regulations (both Central and State) that may be enforced from time to time by the appropriate authorities.TGB shall not be responsible in any manner in the event of non-compliance with various labour laws in force by the Contractor and the onus of compliance lies solely with the Contractor.
- 15. The manpower deployed by the Contractor should be in neat uniform, polite, cordial, positive and efficient, while handling the assigned work so that their actions promote goodwill and enhance the image of TGB. Necessary grooming should be done by the Contractor before posting the staff at site. He shall also comply with the provisions of all labour legislations. Receipt of any complaint in this regard shall be viewed seriously. No additional payment shall be made if Contractor keep more staff at site for completing the pending work or if the minimum staff strength is not able to perform satisfactorily as per the contract provision.
- 16. The Contractor shall abide by all the requirements of maintenance from time to time and shall strictly follow the obligation required by TGB.
- 17. The Contractor should obtain necessary permission that may be required for the purpose of this Contract from such authorities as may be prescribed by Law from time to time.
- 18. The Contractor or his authorized representative should visit the site frequently as required by TGB and meet Officials for any clarifications and to receive instructions.
- 19. The Contractor shall have whole/ sole responsibility for any damage/ loss of life and

property of TGB on the part of any employee engaged by the Contractor resulting in any loss to TGB or any of its clients. The Contractor shall fully compensate TGB for such damage/loss. The decision of TGB in this regard shall be final and binding.

- 20. Any act of indiscipline/ misconduct/ theft/ pilferage on the part of any employee engaged by the Contractor resulting in any loss to TGB or any of its clients in kind or cash will be viewed seriously and TGB will have the right to claim damages or levy fine and/ or terminate the Contract forthwith, if necessary without any notice.
- 21. In case of any default or failure on Contractor's part to comply with all/ any one of the Terms/ Conditions, TGB reserves the right to take necessary steps to remedy the situation including, inter-alia, the deduction of appropriate amount/s from dues otherwise payable to Contractor and/ or by taking recourse to appropriate recovery proceedings.
- 22. If any dispute arises on any matter concerning this Contract, the decision of TGB shall be final and binding.
- 23. The Contractor should not at any time do, cause or permit any nuisance on the site/ do anything which shall cause unnecessary disturbances or inconvenience to the occupants/ visitors at site or near the site of work.
- 24. The work should be carried out with least inconvenience to the staff members of TGB. The workmen employed by the Contractor should abide by the Rules and Regulations maintained by TGB in the premises, especially in respect of working hours, entry of the workers to the premises, wearing of uniforms, interpersonal relation with the staff. The Contractor shall provide photo identity card to its workers. Any workman not maintaining discipline/ decorum inside the premises shall be immediately removed from site.
- 25. The Contractor should obtain approvals, if any, necessary for the work from the statutory bodies. The Contractor shall assist TGB fully in respect of any liaison with the Municipal/Police or any other authority for necessary approval/ permission with regard to the AMC works.
- 26. The Contractor shall provide everything necessary for the proper execution of the works.
- 27. No advance payment shall be made. Further, Contractor will not link payment to his manpower with the settlement of bills by TGB.
- 28. VALIDITY OF TENDER: 120 Days from the date of opening of the Tenders.
- 29. If in the opinion of TGB the work done by the Contractor is not satisfactory, TGB may decide depending upon the merit of the work to deduct such amount from the monthly bill amount as it may deem fit.
- 30. The Contractor shall use necessary safety equipment and maintain all safety measures during the execution of works and ensure compliance of Safety Code as per rules and Regulations in force.

- 31. Contractor shall be required to furnish TGB, as and when required, the following:
  - i) The Power of Attorney, name and signature of his authorized representative, who will be in- charge of execution of this contract.
  - ii) Registration certificate copies.
  - iii) Validity of Insurance Policies, Labour Contract License relating to staff engaged at TGB site. The Contractor shall take all precautions necessary and shall be responsible for safety of work and risk involved in works carried out by their personnel.
  - iv) Contractor shall vouch safe bonafides, conduct and fidelity of the staff employed by him. Any damage caused willfully or in negligence to the works executed, shall be borne by him. The penalties mentioned in Service Level Agreement (SLA) given in Tender Document shall be applicable.
- 32. If a worker's performance or conduct is deemed unsatisfactory, or if they fail to fulfill the assigned tasks, the contractor should be immediately removed from the work site.
- 33. The manpower deployed by the Contractor for discharging the contractual obligations under the contract shall be the employees of the Contractor. TGB shall in no way be connected with such manpower and they shall have no claim whatever against TGB.
- 34. The Contractor shall at his own cost and expenses provide all the materials, labour, supervision tools, ladders, trolleys, conveyance, uniforms etc. required for execution of the work covered by this contract to the entire satisfaction of TGB.
- 35. Notwithstanding anything contained therein the labourers, workmen, supervisors and other employed persons by the Contractor for the purpose of the works shall for all purposes be regarded as the Contractor's employees. Therefore, neither the Contractor nor any of such employees shall have any right to complain or claim against TGB. TGB also shall have no concern with them and shall not be liable to make any payment to or any contribution on account of them.
  - a) The tender is neither an agreement nor an offer and is only an invitation by the Bank to the interested parties for submission of their bids/ offers.
  - b) The information contained in this document or information provided subsequently to the bidders whether verbally or in documentary form by or on behalf of TGB is provided to the bidders on the terms and conditions set out in this tender document and all other terms and conditions subject to which such information is provided.
  - c) The purpose of this tender is to provide the bidders with information to assist the formulation of their bids/ proposals. This tender does not claim to contain all the information each bidder may require. Each bidder should conduct his own investigations and analysis and should check the accuracy, reliability and completeness of the information in this tender and, wherever necessary, may obtain independent advice.
  - d) Bank makes no assertion or warranty and shall incur no liability under any law,

statute, rules or regulations as to the accuracy, reliability or completeness of this tender. Bank may in its absolute discretion, but without being under any obligation to do so, update, amend or supplement the information in this tender.

- 36. The contract shall be valid for three (03) years from the date of agreement. The Bank also reserves the right/ option to extend the validity of this contract at the same rates for a period of one (01) or more years and on the same terms and conditions, with consent from the vendor.
- 37. Forfeiture clause: In case of negligence/ dereliction of duty by Contractor's staff, the above contract shall be terminated without giving any notice by the Bank and the security deposit shall be forfeited.
- 38. Recovery of GST-TDS, income tax, education cess, work contract tax, goods and service tax etc. as applicable & in force shall be deducted from the bill during the currency of the contract.
- 39. The property shall be handed over to Contractor for AMC on as-is-where-is basis.
- 40. The vendor should submit his tender well in advance so that last minute technical glitches can be avoided and TGB will not be responsible for failure of submission of tender by the bidders in this regard. "No extension of time will be permitted if the vendor is facing difficulty or facing technical issues in uploading the document at the fag end of the time specified for closure of tender".
- 41. The Bank, at its sole discretion, may invite the L-2 bidder/ vendor to match the L-1 rates discovered during the tender process. In the event that the L-2 bidder agrees to match the L-1 rates, the Bank reserves the right to distribute the total order quantity between the L-1 and L-2 vendors in a 60:40 ratio, with 60% allocated to L-1 and 40% to L-2. However, this allocation is entirely at the discretion of the Bank, and the Bank reserves the right to alter the ratio, cancel the split arrangement, or place the entire order with the L-1 bidder if deemed appropriate, without assigning any reason.
- 42. In the event of unsatisfactory performance by any of the finalized vendor(s)/bidder(s), the Bank reserves the right to terminate the contract at its sole discretion. The Bank may also assign the entire work order to another eligible bidder/vendor, if deemed necessary.
- 43. Upon satisfactory performance and delivery of services during the initial contract period, the Bank reserves the right, at its sole discretion, to extend the contract for an additional period of one (1) or more years on the same terms and conditions. The decision to extend the services shall be based on the vendor's adherence to service-level agreements, quality of support provided, and overall performance as evaluated by the Bank. However, such an extension shall not be treated as a right by the vendor and shall be solely at the discretion of the Bank.

#### SPECIAL TERMS AND CONDITIONS - SCOPE OF WORK

### Scope of Work (Part A)

- 1. This contract shall be valid for a period of three years from the date of agreement. In the event of TGB requiring the services for further periods after the expiry of the initial period, extension of contract up to one year shall be considered upon seeing the satisfactory service of the Contractor and as per existing terms and conditions mentioned in the tender documents and the agreement/ contract.
- 2. No overtime allowance or any compensation of any other kind shall be payable by TGB to any person including supervisor employed by the Contractor for duties at the Bank premises.
- 3. TGB shall deduct income tax and other taxes which it may be required under any law for the time being in force from the payment to be made to the Contractor for the services rendered to TGB.
- 4. During the continuance of this contract or such extended time, the Contractor shall provide supply, installation and AMC for fire extinguishers services as per the requirement of the Bank. The present requirement indicated in the scope of work would be liable for change as and when considered necessary by the TGB.
- 5. The staffs on duty shall be medically fit to perform the supply, installation and AMC for fire extinguishers service. They will be the employees of the Contractors under their exclusive control and supervision and shall comply with the following:
  - i) The Contractor's staff on duty shall comply with all directions and instructions issued by the authorized representatives of TGB regarding the supply, installation, and annual maintenance of fire extinguisher services, as communicated from time to time.
  - ii) The Contractor shall ensure that all personnel deployed are well-groomed, suitably educated, and of high integrity. They shall maintain proper discipline at all times and shall not, in any manner, cause interference, annoyance, or nuisance to the management of TGB, its business operations, officers, employees, or visitors.
- 6. The Contractor shall comply with all statutory requirements in respect of their staff such as ESIC coverage, Provident Fund, payment of bonus, payment of minimum wages, dearness allowance, leave and gratuity benefits and other legal and statutory requirements in relation thereto and TGB shall not have any liability in this regard. All such liabilities shall be discharged by the Contractor promptly without any default.
- 7. The Contractor shall indemnify TGB against all claims, demands proceedings, damages, costs, charges and expenses whatsoever in respect thereof or in relation thereto. The Contractor shall defend all actions arising from such claims, before any such

infringement and receive their permission to proceed, and shall himself pay all royalties, license fees, damages, costs and charges of all and every sort that may be legally incurred in respect thereof. The Contractor, before starting the work of execution of the service contract as described under scope of work, is required to submit a "Letter of Indemnity and Undertaking". A specimen of such letter is enclosed as Annexure II.

8. TGB will not be under any liability to pay any compensation to the staff deployed by the Contractor for their sustaining any injury etc. while discharging the duties in the Bank

premises.

9. TGB shall, in the event of the Contractor committing any breach of any of the terms and conditions of this agreement or if the services provided by the Contractor is considered to be unsatisfactory by TGB, be entitled to terminate this agreement by giving thirty (30) days' notice in writing and the Contractor shall not be entitled to any compensation for

such termination.

10. In case of any dispute or difference between the parties under this agreement, the same shall be referred to The Chairman, TGB, Head Office, Hyderabad or to the person

nominated by him and his/her decision shall be final and binding on the parties.

11. It is advised that vendors may submit scanned copies of all documents in support of their claims / submissions, as asked for in the tender document of TGB, along with an undertaking that all documents submitted are true and correct and if found false or otherwise,

in future, will be liable for termination of the tender/ contract without any notice.

The "TGB" and the "Vendor" are hereinafter collectively referred to as the 'Parties' and individually referred to as the 'Party'.

WHEREAS the TGB is desirous of carrying out the work of **Annual Maintenance Contract for supply, installation, refilling and AMC service of Fire Extinguishers at 934 branches and Administrative Offices located in Telangana State** and have caused specifications describing the work to be done and prepared by TGB Head Office, Hyderabad.

AND WHEREAS the Vendor has visited the site and fully understood the existing conditions of site for execution of work.

AND WHEREAS the Vendor has successfully submitted the tenders and declared as successful bidder.

AND WHEREAS the Vendor has agreed to execute upon and subject to the conditions set forth in the Price Bid and Conditions of Contract (all of which are collectively hereinafter referred to as "the said Conditions") the work shown upon the said technical specifications, and included in the Price Bid at the respective rates therein set forth amounting the sum as therein arrived or such other sum as shall become payable there under (hereinafter referred to as "the said contract amount").

## NOW, THE AGREEMENT WITNESS THAT IT IS MUTUALLY AGREED BY AND BETWEEN THE PARTIES:-

- 1. In consideration of the said Contract amount to be paid at the times and in the manner set forth in the said conditions, the vendors shall upon and subject to the said conditions annexed, carry out, execute and complete the supply/work shown in the contract, described by or referred to in the schedule of quantities and in the said conditions.
- 2. The said Conditions and Appendix thereto and the documents attached hereto shall be read and construed as forming part of this Agreement and the parties hereto shall be respectively abide by, submit themselves to the said Conditions and the correspondence and perform the agreements on their part respectively in the said conditions and the documents contained herein.

- 3. The Scope of work and all the terms and conditions as enumerated in this tender is part and parcel of this agreement and binding on the parties. The vendor shall ensure that all items of work specified in the scope of work is attended to. In case of difference between the tender document and this agreement, the agreement will prevail.
- 4. This Agreement and documents mentioned herein shall form the basis of this contract.
- 5. TGB reserves to itself the right of altering the nature/quantum of the work by adding to or omitting any items having portions of the same carried out without prejudice to this Contract.
- 6. The Vendor shall provide to TGB a security deposit of Rs.\_\_\_\_\_/ (Rupees Only) (Interest Free).
- 7. In case of breach of any terms and conditions attached to this contract, the Security deposit of the Vendor will be liable to be forfeited by TGB besides annulment/ termination of the contract.
- 8. In case any of the documents furnished by the Vendor is found to be false at any stage, it would be deemed to be a breach of terms of Contract making him/her liable for legal action besides termination of contract.
- 9. The TGB shall pay the said contract amount, or such other sum as shall become payable, at the times and in the manner specified in the said Conditions.
- 10. All payments by the TGB under this contract will be made only at Head Office, Hyderabad.
- 11. The Vendor shall indemnify and keep indemnified, defend and hold good TGB, its staff and agents against loss, damages or claims arising out of any violations of applicable laws, regulations, guidelines during the contract period and for the breach committed by the Vendor or their personnel on account of misconduct, omission and negligence by the Vendor or his staff.
- 12. TGB shall not be responsible for any damages, losses, Claims, financial or other injury to any person/s engaged by Vendor in the course of their performing the functions/works, or for payment towards any compensation.
- 13. Time shall be considered as the essence of this contract, and the Vendor hereby agrees to commence the work/ job on the next day of receipt of the work order as provided for in the said conditions and to complete the entire work within the time period prescribed in the tender document reckoned from the date of receipt of such work order subject nevertheless to the provision for extension of time.
- 14. TGB reserves the right to withdraw/relax any of the terms and conditions mentioned above so as to overcome the problem encountered by the contracting parties.
- **15. Contract Period:** The contract shall be valid for a period of three (03) years from the date of awarding the contract, subject to review yearly, based on satisfactory performance of the firms/ vendor. The contract may further extend as deemed necessary by the TGB on the existing rate, terms, and conditions.
- **16. Obligations of the Bidder/ Vendor:** The Bidder/ vendor is responsible for managing the activities of its personnel and will hold itself responsible for any misdemeanors.
- **17. Indemnity:** The selected vendor shall indemnify, protect and save the TGB against all claims, losses, costs, damages, expenses, action suits and other proceedings, resulting from

infringement of any law pertaining to labour act, minimum wages act, engaging the manpower laws etc.

- 18. Selected Bidder shall keep the TGB, its Successors, Assignees and Administrators fully indemnified and harmless against loss or liability, claims actions or proceedings, if any, that may arise from whatsoever nature caused to the TGB through the action of its employees, agents, Contractors, Sub-Contractors etc.,
- 19. The indemnification is only a remedy for the TGB. The Selected Bidder is not absolved from its responsibility of complying with the statutory obligations as specified in the tender documents terms and conditions. Indemnity would be limited to court awarded damages and shall exclude indirect, consequential and incidental damages. However, indemnity would cover damages, loss or liabilities suffered by the TGB arising out of claims made by its customers and/ or regulatory authorities.
- 20. However, the Selected Bidder would be given an opportunity to be heard by the TGB prior to making decision in respect of such loss or damage.
- **21.** Liability of the Selected Bidder: TGB shall hold the selected bidder, its Successors, Assignees and Administrators fully liable against loss or liability, claims, actions or proceedings, arising out of non-fulfillment of any obligations under the Contract.
- 22. Selected Bidder shall be the principal employer of the employees, agents, contractors, Sub-Contractors etc. engaged by the firm and shall be vicariously liable for all the acts, deeds or things done by its employees, agents, contractors, Sub-Contractors etc., whether the same is within the scope of power or outside the scope of power, vested or instructions issued by the TGB under the contract to be issued for this Tender Document.
- 23. Negligence by the Bidder: In connection with the work or contravening to the provisions of General Terms, if the selected bidder neglects to execute the work with due diligence or expedition or refuses or neglects to comply with any reasonable order given to him in writing by the TGB, in such eventuality, the TGB may after giving notice in writing to the selected bidder calling upon him to make good the failure, neglect or contravention complained of, within such time as may be deemed reasonable and in default of the said notice, the TGB shall have the right to cancel the contract holding the selected bidder liable for the damages that the TGB may sustain in this behalf.
- **24. Termination of the Contract:** The TGB reserves its right to cancel the entire contract in whole or part at any time without assigning appropriate reasons in the event of one or more of the following conditions:
- 25. Delay in completion of the work beyond the specified periods for reasons solely ascribed to the bidder.
  - i) More than received three show cause notice from the TGB side, the TGB may at its discretion terminate this agreement.
  - ii) Serious discrepancies noted in the conduct of the work.
  - iii) Breaches in the terms and conditions of the contract.
  - iv) If the bidder fails to perform any other obligation(s) under this Tender/and subsequent agreement.
- 26. Notwithstanding anything herein contained, the TGB may, by giving 30 (thirty) days notice in writing to the service provider, terminate the contract under any one or more of the following conditions:

- i) If at any stage, even after the award of the contract, it comes to the notice of the TGB, that the Bidder had used fraudulent methods or falsified documents to obtain the contract, the TGB would be at liberty to terminate the contract without any notice and a penalty as deemed appropriate would be imposed on the vendor.
- ii) The TGB may terminate the contract if it is found that the Bidder is black listed on previous occasions by any of the TGBs / Institutions / Local Bodies/ Municipalities / Public Sector Undertakings, etc.
- iii) The TGB may terminate this agreement before the determination of the contract period (i.e., three years) for any reason whatsoever or without assigning any reason thereto after giving one month's notice period to the Vendor.
- Iv) In the event of any default by the Bidder, if in the reasonable opinion of the TGB, performance of any of the services under this tender by the Bidder is not acceptable as being in contravention of any law as may be applicable from time to time or industry practice, under the circumstances which would amount to objectionable service or for any reason TGB decides to discontinue and/or dispense with service for any administrative reasons or otherwise.
- v) If the Bidder fails to perform the services under this Tender Notice or to observe any obligations or breaches all or any of the terms of this Tender Notice or the service provider is adjudged insolvent by any court of law or the service provider's service is declared by any court of competent jurisdiction as illegal, sham, or contrary of any law.
- 27. If a petition for insolvency is filed against the service provider and such petition is not dismissed within ninety (90) days after filing and / or if the service provider makes an arrangement for the benefit of its creditors or, if the Court Receiver is appointed as receiver of all / any of the service provider's properties.
- 28. If in the opinion of the TGB, the interests of the TGB are jeopardized in any manner whatsoever.
- 29. Nothing contained in this Tender shall affect the right of the TGB to terminate the contract with immediate effect in the event of the happening of all or any of the cause stated in this clause.
- 30. Notwithstanding the above, if the service provider discontinues its business at any point of time due to any reason whatsoever, the Bidder shall give notice in writing, 30 days prior to the closure of discontinuing the business to the TGB and shall give all assistance to the TGB till the services hereto handled by the service provider is suitably transferred to other Agencies and/ or taken over by the TGB. The closure shall not discharge the service provider from providing such information and maintaining the records as stated hereinbefore.
- 31. Any one instance of non-payment of any of its employee EPF or ESIC contribution or less payment of EPF and ESIC contribution or less payment of wages without any reason will result in termination of contract and security deposit will be forfeited. The Bidder will not be allowed to take part in any empanelment process for next three years.
- 32. It shall be open for TGB to terminate the agreement on the death, retirement, insanity or insolvency of any person/s, being director/s or partner/s, in the said company / firm or on the addition or introduction of a new partner without the previous approval in writing of TGB. But in the absence of and until its termination by TGB as aforesaid, this agreement shall continue to be of full force and effect notwithstanding any changes in the constitution of the firm by death, retirement, insanity or insolvency of any of its partner or the addition or introduction of any partner. In case of retirement/ death, the surviving or remaining partner of the firm shall

be jointly and severally liable for the due and satisfactory performance of the terms and conditions of the agreement.

- **33.** Effect of Termination: The TGB shall make such prorated payment for services rendered by the bidder/ vendor and accepted by the TGB at the sole discretion of the TGB in the event of termination, provided that the bidder is in compliance with its obligations till such date. However, no payment for "costs incurred, or irrevocably committed to, up to the effective date of such termination" will be admissible. There shall be no termination compensation payable to the bidder. Termination shall not absolve the liability of the TGB to make payments of undisputed amounts to the bidder for services rendered till the effective date of termination. Termination shall be without prejudice to any other rights or remedies a party may be entitled to hereunder or at law and shall not affect any accrued rights or liabilities of either party nor the coming into force or continuation in force of any provision hereof which is expressly intended to come into force or continue in force on or after such termination.
- **34. Publicity:** The Firms shall not use logo and name of the TGB on their letter head, sign board and rubber stamp etc. Any publicity by the selected bidder in which the name of the TGB is to be used should be one only with the explicit written permission of the TGB.
- **35. Inspection of Records:** All bidder's records with respect to any matter covered by this Tender Document shall be made available to the TGB or its authorized officials at any time during normal business hours, as often as the TGB deems necessary, to audit, examine, and make excerpts or transcripts of all relevant data. Said records are subject to examination.
- **36. Non-disclosure of Information:** The Selected Bidder shall not, without the TGB's prior written consent, disclose any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the TGB in connection therewith, to any person other than a person employed by the Bidder in the performance of the work assigned to them.
- 37. The Vendor/ Contractor shall not disclose directly or indirectly any information, materials and details of the TGB's infrastructure / systems / equipment etc., which may come to the possession or knowledge of the Contractor during the course of discharging its contractual obligations in connection with this agreement, to any third party and shall at all times hold the same in strictest confidence. The Contractor shall treat the details of the contract as private and confidential, except to the extent necessary to carry out the obligation under it or to comply with applicable laws. The Contractor shall not publish, permit to be published, or disclose any particulars of the works in any trade or technical paper or elsewhere without the previous written consent of the Employer. The Contractor shall indemnify the employer for any loss suffered by the Employer as a result of disclosure of any confidential information. Failure to observe the above shall be treated as breach of contract on the part of the Contractor and the Employer shall be entitled to claim damages and pursue legal remedies. The Contractor shall take all appropriate actions with respect to its employees to ensure that the obligations of non-disclosure of confidential information under this agreement are fully satisfied. The Contractor's obligations with respect to non-disclosure and confidentiality will survive the expiry or termination of this agreement for whatever reason.
- **38. Jurisdiction of the Court:** The Courts in Telangana State shall have the exclusive jurisdiction to try all disputes, if any, arising out of this agreement between the parties.
- **39. Vicarious Liability-** The Vendor/ Service Provider shall be the principal employer of the employees, agents, Contractors, Sub-Contractors, etc., if any, engaged by the Service Provider and shall be vicariously liable for all the acts, deeds, matters or things, whether the same is within the scope of power or outside the scope of power, vested under the contract. No right of any employment in the TGB shall accrue or arise, by virtue of engagement of

employees, agents, Contractors, Sub-Contractors etc., by the Service Provider for any assignment under the contract. All remuneration, claims, wages dues etc., of such employees, agents, Contractors, Sub-Contractors etc., of the Service Provider shall be paid by the Service Provider alone and the TGB shall not have any direct or indirect liability or obligation, to pay any charges, claims or wages of any of the Service Provider 's employees, agents, Contractors, Sub-Contractors etc.

40. The Vendor/ Service Provider shall agree to hold the TGB, its successors, assigns and administrators fully indemnified, and harmless against loss or liability, claims, actions or proceedings, if any, whatsoever nature that may arise or caused to the TGB through the action of Service Provider's employees, agents, Contractors, Sub-Contractors, etc.

#### 41. Dispute Resolution:

- a) In case of dispute regarding the quality of work and product / unsatisfactory services etc., the final authority will rest with the General Manager-VI, TGB, Head Office, Hyderabad and the same will be binding on the Vendor.
- b) In the event of any claim, difference, dispute or controversy and questions whatsoever arising between the parties under this agreement and subsequent agreement shall in the first instance, be attempted to be resolved between the parties themselves.
- c) If the dispute cannot be resolved through consultations between the Parties within 30 (thirty) days after 1(one) Party has served a written notice on the other Party requesting the commencement of such discussions, any Party may thereafter in writing, demand that the dispute be finally settled by an arbitration comprising of sole arbitrator mutually appointed by the Parties in accordance with the Arbitration and Conciliation Act, 1996 or any modifications thereof. The arbitrator shall be a person of professional repute who is not directly or indirectly connected with any of the parties to this Agreement and shall have prior experience as Arbitrator. The arbitration proceedings shall be governed by the Arbitration and Conciliation Act, 1996. The seat and venue of arbitration shall be Hyderabad. The language of arbitration shall be English.
- d) The award of the arbitrator/s so appointed shall be final and binding on the parties.
- e) Work under the contract shall be continued by the Vendor during the arbitration proceedings unless otherwise directed in writing by TGB. No payment due, or payable by TGB, to the Vendor shall be withheld on account of the ongoing arbitration proceedings, if any, unless it is the subject matter, or one of the subject matters thereof Or on account of existing substantial loss/pending penalty proceedings due to the acts of Vendor.
- 42. If the vendor becomes insolvent or found to have offered any bribe in connection with the contract or the Vendor fails to observe or perform any condition of this contract then notwithstanding any previous waiver of such default or action being taken under any other clause hereof, TGB may terminate the contract and forfeit the said security deposit and recover from the Vendor any loss suffered by TGB on account of the contract being terminated.

- 43. This agreement is being executed in duplicate, TGB shall keep the original and the Vendor shall keep the duplicate.
- 44. The Vendor shall bear the expenses for stamp duty on this agreement for both the original and the duplicate copy.
- 55. In case of Fire Extinguisher while servicing, if any refill is found to be leaked or pressure has gone down, fully or partially or any other defect is found, the same will be brought to notice of the Branch Manager. Accordingly, the refilling will be done only after rectification of the defect, notwithstanding the periodicity of refilling.
- 46. No amendment to this Agreement shall be effective unless it is in writing and signed by duly authorized representatives of both the parties hereto with the mutual written consent.
- 47. That the several parts of this contract have been read by the Vendor and fully understood by the Vendor.
- 48. Both party warrants and guarantees that it has full power and authority to enter into and perform this Agreement and the person signing this Agreement on behalf of each has been properly authorized and empowered to enter into this Agreement. Each party further acknowledges that it has read this tender/ work order/ Agreement and understands it, and agrees to be bound by it.
