1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. 3. 4. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. **1. Scope of standard installation and commissioning for Wall Mount Split AC consist of follows:**

- a)** Installation/Commissioning is mandatory for all types of purchases (Direct/L1/Bid). For cases where Installation/Commissioning is not required, the buyer may indicate the details in the bid document.
- b)** The Switches/ Sockets/ Plug Tops/ Voltage Stabilizer/stand for ODU/ Chiselling/ Ducting/ Grooving for concealing the refrigerant piping/cabling/ core cutting of the wall are not included in the scope of standard installation and commissioning, unless otherwise mentioned in the contract.

The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

## **II. ELIGIBILITY CRITERIA: TECHNICAL EVALUATION:**

- 1. Manufacturer Authorization Form (MAF):** The OEM should provide a “**Bid-specific Manufacturer Authorization Form (MAF)**” in favour of the bidder, clearly indicating the name, designation, and contact details of the authorized signatory. The Bank reserves the right to verify the authenticity of the MAF and the signatory.
- 2. Turnover:** The OEM should have a minimum average turnover of ₹1,000 Crore and The bidder should have a minimum average turnover of ₹1.40 Crore in India in the last three financial years supported by audited balance sheets.
- 3. Make in India Compliance:** The OEM shall submit a valid declaration confirming compliance with “Make in India” guidelines, including details of local content as per Government of India norms.
